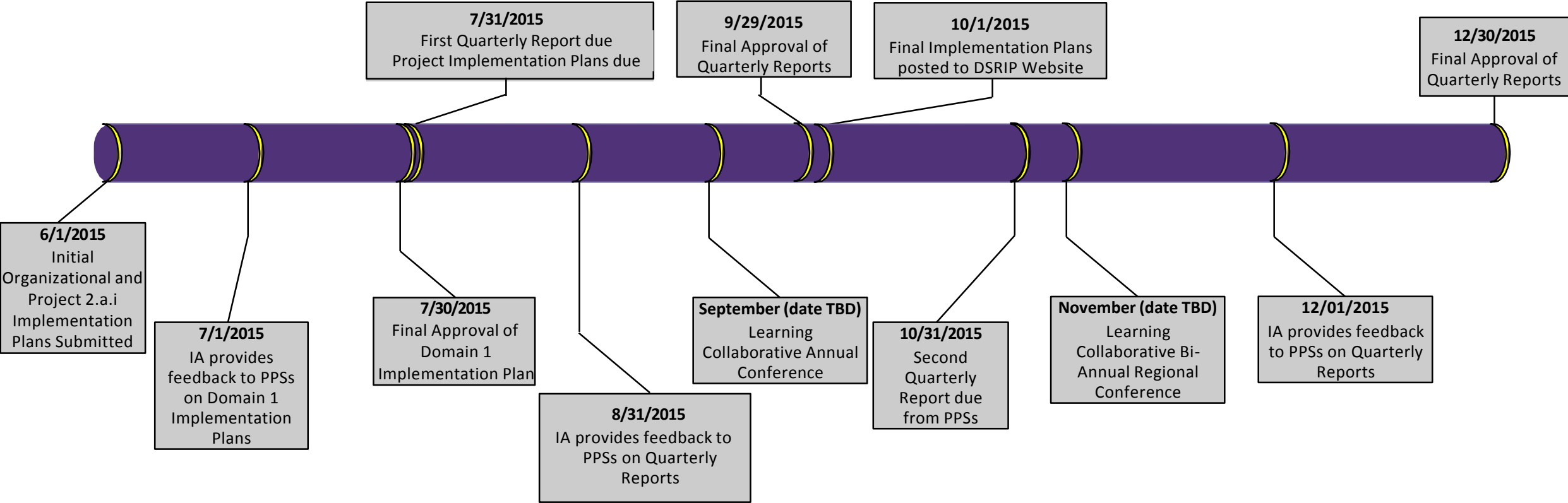

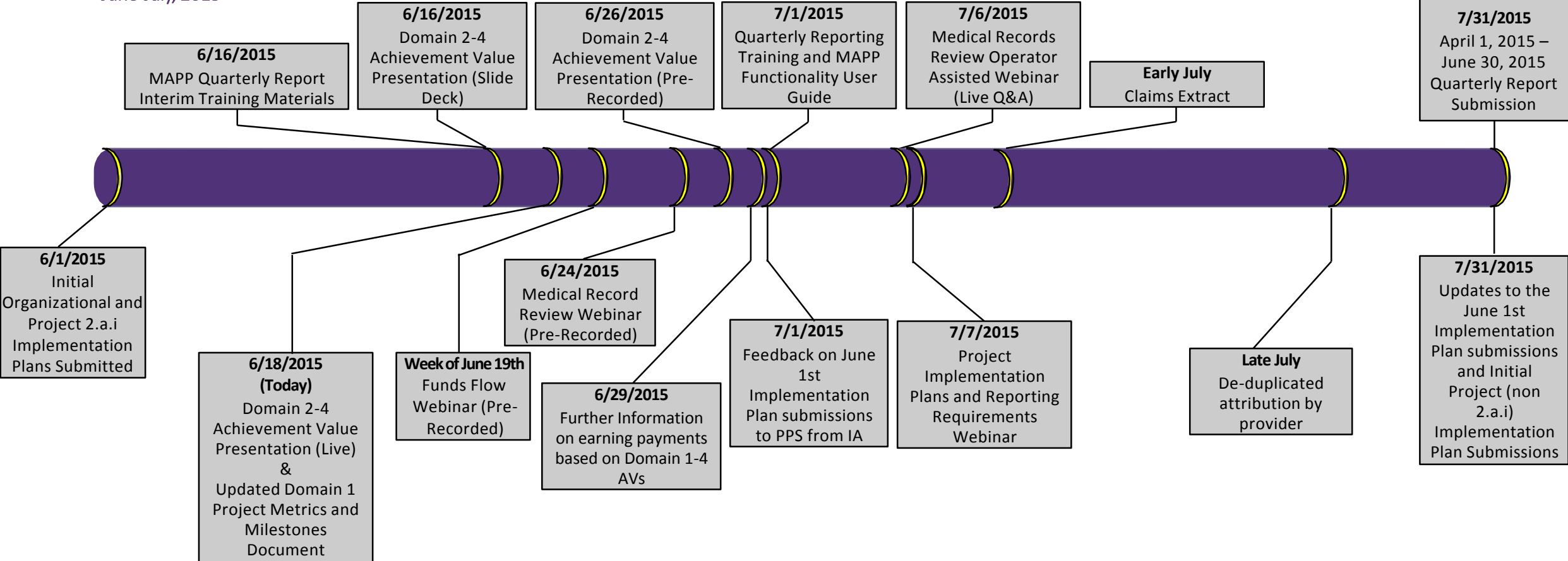
DSRIP High-level Timeline: 6 month view

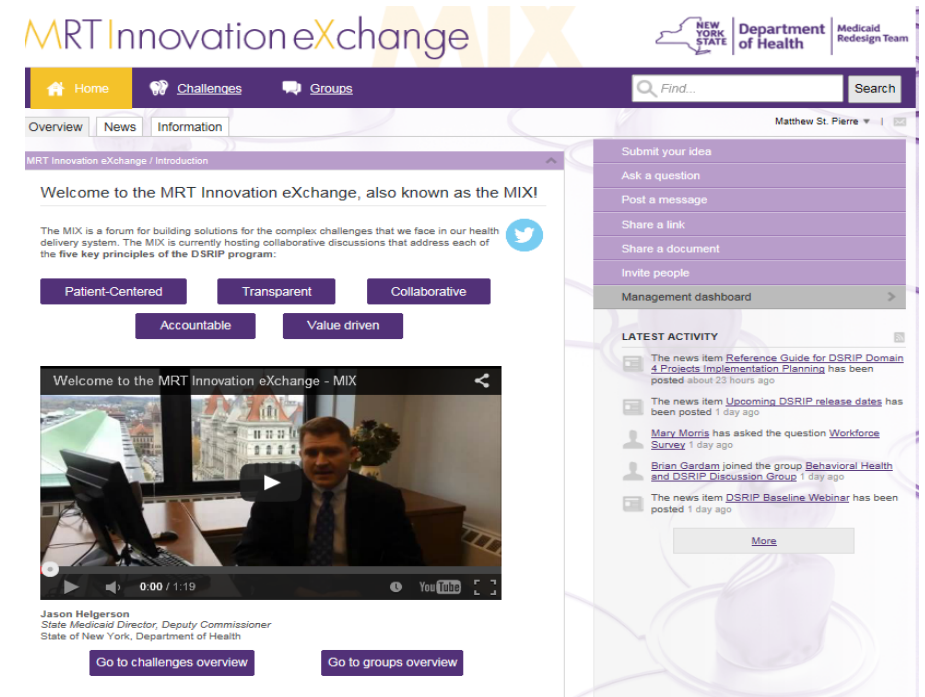
