## Skill building

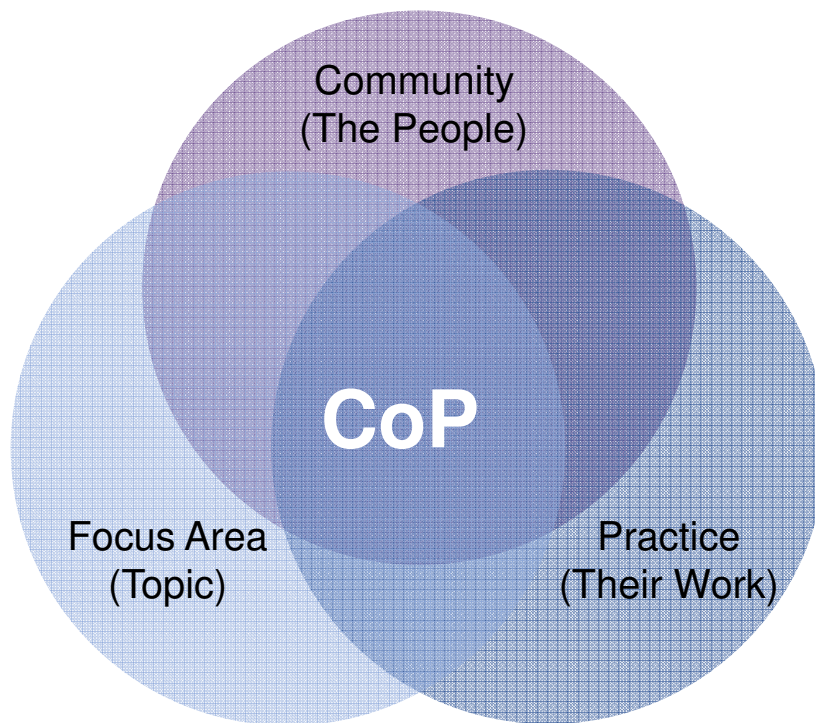

- Voluntary membership driven by commitment and competence
- Collective learning, knowledge and resource exchange
- Distributed leadership
- Duration based on commitment and value

# CoP Focus Area Identified by PPS

PPS Survey	Results
Value Based Payment	43
Addressing Social Determinants	16
Partnering with CBOs	14
Care Management	11
None	4

## Value Based Payment

- Working with MCOs and CBOs: Contract design, impact assessment, and performance attribution
- Shifting from RVU to VBP, bonus payments and risk sharing
- Using data to assess value
- Sharing information to realize value

# How CoPs Differ

Characteristics	Existing Structures	CoP
Function	Deliver a product, service or task	Develop members' shared capabilities and exchange knowledge
Membership & leadership	Assigned with reporting to a group manager or leader	Voluntary with leadership determined by its members
What holds it together	Job requirements	Passion, commitment and identification with the group's focus areas
Duration	Pre-defined with milestones	Stays together as long as its members are interested in maintaining the group
