Workshop C. - How to Roll-out Effective HIT Management to PPS Partners

- i. What areas are you prioritizing in developing an HIT plan for your PPS (e.g., interoperability, EHR and HIE adoption, utilization, privacy/security, and training)?
- ii. How thorough is the data you have about providers in your PPS regarding their status of HIT adoption and practice capabilities?
 - a. Have you stratified providers based on their HIT adoption/capabilities status (e.g., prioritizing the late adopters to get them started sooner)?
 - b. What approach did you or would you take to do that?
- iii. What strategies have been successful to date in managing HIT roll-out across your PPS? (e.g., technical assistance, contracting, and vendor relationships)?
- iv. What are some promising practices for training on and the use of Regional Health Information Organizations (RHIOs) to share data across PPS (e.g., the strategy for getting providers to sign up with the local RHIO)?
 - a. Have you met with (or do you have plans to meet) with RHIO partners that support your provider geos to align on messaging about HIE participation?
 - b. Are you using data about your providers to target messaging to those not connected or utilizing the RHIO HIE?
 - c. Are you planning to identity those providers eligible for and ideal to enroll in Data Exchange Incentives?
