#### MEIPASS Open for 2018 Meaningful Use Attestations

MEIPASS is **NOW OPEN** for Payment Year 2018 Modified Stage 2 and Stage 3 Meaningful Use (MU) attestations!

For Payment Year 2018, the full attestation can be completed within MEIPASS and the deadline is September 30, 2019.

**Important Note:** Providers who used an impacted Greenway Health LLC certified electronic health record technology (CEHRT) product are advised to not attest to Payment Year 2018 with the NY Medicaid EHR Incentive Program at this time. Greenway Health LLC is continuing to fix issues found with certain EHR products that are calculating Promoting Interoperability (Meaningful Use) measures incorrectly.

The NY Medicaid EHR Incentive Program will be providing attestation deadline accommodations to providers using Greenway products impacted by this issue who submitted a Greenway Health LLC Identification Form
