Payment Year (PY) 2019 Attestation Announcement

The NY Medicaid EHR Incentive Program will accept PY 2019 Meaningful Use Attestations in MEIPASS beginning on **February 3, 2020**.

Before you attest in MEIPASS, please make sure the following items are available and up to date:

- CMS registration
- Medicaid Fee-For Service Enrollment
- ETIN Certification
- ePACES/MEIPASS credentials
- Payee affiliation
- CEHRT ID for 2019 Meaningful Use
- Contact information in MURPH
- Security Risk Assessment for calendar year 2019
