## Payment Year (PY) 2020 Attestation Deadline Extension (ADE) Submission Deadline

### The PY2020 ADE Submission Period ends today.

If you were not able to submit your attestation by the regular deadline due to extenuating circumstances, you may be able to submit an **Attestation Deadline Extension (ADE)**. ADEs will be accepted until 11:59PM today, **March 1st, 2021**. Providers who are granted an ADE will have until **March 31st, 2021** to submit their PY2020 attestations.

## Payment Year (PY) 2021 Pre-Validations

Pre-Validations involve submitting Medicaid Patient Volume information prior to the payment year opening for validation. This can help providers avoid patient volume remediation during the attestation process and can allow them to be approved for payment sooner.

### Pre-Validations for PY2021 will be accepted from March 15th, 2021 to June 11th, 2021.

If you would like to take advantage of this service to avoid patient volume remediation during the official or soft opening attestation periods, please begin the process of finding a suitable Medicaid patient volume reporting period. **For PY2021, providers must utilize a MPV Reporting Period within Calendar Year 2020 to be eligible for Pre-Validation.** Providers who wish to use a MPV Reporting Period from within 2021 will not be eligible for this service.

A second message including the Pre-Validation templates and additional instructions for this process will be sent later this week.
